

Re-Invitation for Bids

Supply, Delivery, Installation and Commissioning of Four Color Sheet-Fed Offset Press
Machine with perfecting and CTP Offline

1. The Department of Printing (DoP), Kathmandu, Nepal invites sealed bids from eligible and qualified bidders for the Supply, Delivery, Installation and Commissioning of slice 1 Four Color Sheet-Fed Offset Press Machine and slice 2 CTP Offline. The bidder can submit the bid for one or both slices and offer discounts/ cross discounts. Evaluation will be done slice by slice, with contracts awarded based on the award combination that is of least cost to the Purchaser. Bidders who are not manufacturers shall submit an authorization from the concerned manufacturer clearly stating that they are the authorized agents of the manufacturer in the format included in Section IV Bidding Forms.
2. Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures specified in the Public Procurement Act, 2007 and Public Procurement Regulations, 2007.
3. Interested eligible bidders may obtain further information from and inspect the Bidding Document at the address given below during 10:00 to 17:00 hours on office days.
4. A complete set of Bidding Documents with specification in English may be purchased by interested bidders at the address given below within June 2, 2010 during office hours on the submission of a written application and cash payment of a non refundable fee of NRs. 5000.00 for each set. If so requested, the Biding Documents can also be sent by courier services upon payment of additional cost of NRs. 2500.00. However, the Purchaser will not be responsible for delay or non-delivery of the documents so sent.
5. Bids must be delivered to the address below on or before **12:00 hours (local time)** on June 03, 2010. **Bids** shall be valid for a period of 90 days and shall be accompanied by a bid security, in the form of an unconditional Bank Guarantee in the format prescribed in the bid documents, *amounting to a minimum of 2.5 % of the quoted bid amount*, which shall be valid for 30 days beyond the bid validity period. (i.e. till September 30, 2010).
6. Late bids will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend at **12:30 hours (local time)** on June 3, 2010 at the address below.
7. If the deadline for purchase or submission of bids falls on official holiday, it shall be extended to the next working day.
